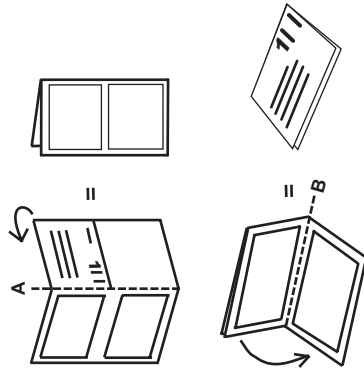
FOLDING INSTRUCTIONS
